

**Resolution for Adoption by the Board of Education of the  
MARTIN LUTHER KING JR., EDUCATION CENTER ACADEMY  
2024-2025 General Fund Budget**

Be it resolved, that this resolution shall be the general appropriations of the Martin Luther King, Jr. Education Center Academy for the **2024-2025** fiscal year, a resolution to make appropriations; to provide for the expenditure of the appropriations and to provide for the disposition of all revenue received by the Martin Luther King, Jr. Education Center Academy.

Be it further resolved, that the total revenues and unappropriated fund balance estimated to be available for appropriation in the general fund of the school district for fiscal year **2024-2025** be used for operating purposes is as follows:

Further resolved, that no board of education member or employee of the school district shall expend any funds or obligate the expenditures of any funds except pursuant to appropriations made by the board of education and in keeping with the budgetary policy statement hitherto adopted by the board. Changes in the amount appropriated by the board shall require approval of the board with exception to the following: Budget Transfer: The Board of the Martin Luther King, Jr. Education Center Academy will permit the Chief Administrative Officer the ability to execute transfers within limits through utilizing a "Request for transfer of funds form" that must be signed by Board Secretary or Treasurer. This request is in accordance to what is stated in the general appropriations act between appropriations without the prior amendment approved by the school board (MCL 141.439).
